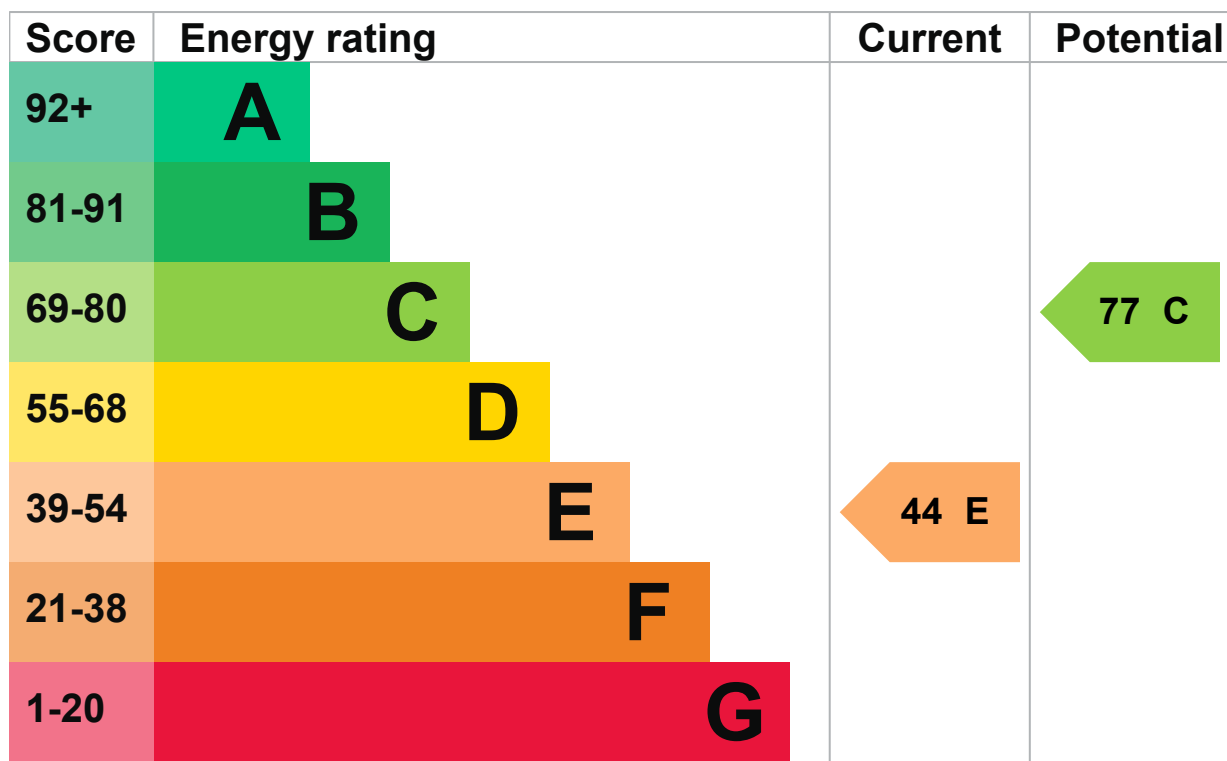

How this affects your energy bills

An average household would need to spend **£1,664 per year on heating, hot water and lighting** in this property. These costs usually make up the majority of your energy bills.

You could **save £340 per year** if you complete the suggested steps for improving this property's energy rating.

Yes. Each step builds on the one before it so you can save the most energy.

For example, it's more energy efficient to insulate your home before you buy a new boiler. A well insulated home will lose less heat so you do not have to run your boiler as often.
