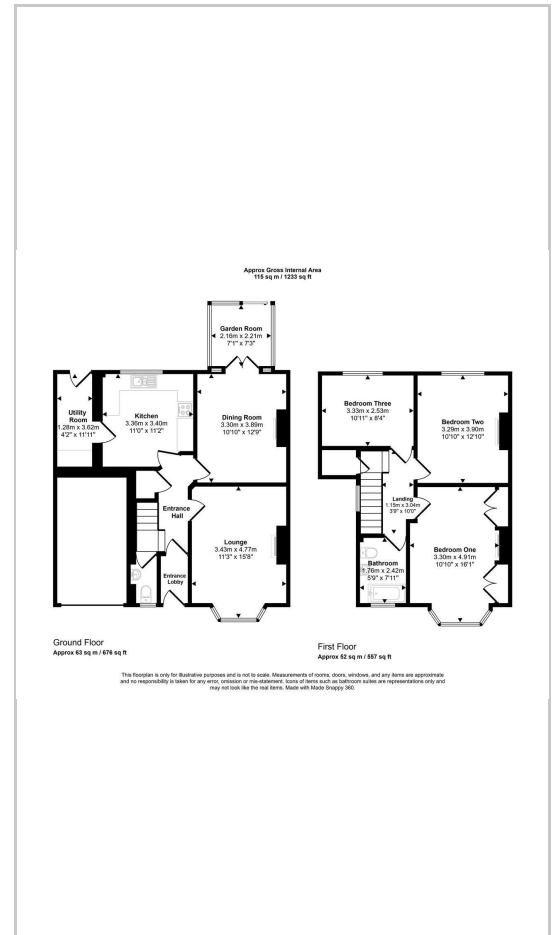

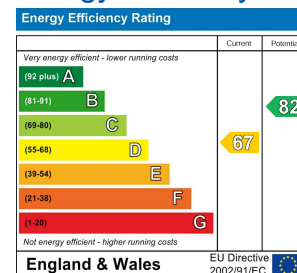
Area Map
