Upon entering the ground floor you are welcomed into an entrance hallway with useful under stairs storage, whilst stairs lead to the first floor.

The living room is a bright and airy space featuring a log burner effect electric fire set on a stone hearth with a rustic mantel beam, creating a beautiful focal point to the room.

The kitchen is fitted with a range of wall and base units, incorporating a Neff oven with slide under door and ceramic hob. Space and plumbing for a washing machine along with space for a freestanding fridge freezer. A door leads out to the garden. Flowing seamlessly through to the dining room, there is ample space for a dining table and chairs, with double doors opening into the garden, making this the perfect space for families and entertaining.

The first floor houses two well proportioned double bedrooms and one single bedroom, with the single room being versatile to suit your family's needs. Bedroom one benefits from a useful storage cupboard. Completing this floor is the house bathroom, comprising a three piece suite including a shower over the bath.
