The bungalow is set in the much sought after village location of Long Marston in a very quiet cul-de-sac location within walking distance to Long Marston Primary School, Church and The Queens Head pub, and within a mile or so of Cheddington Station.

The light, welcoming hallway leads to two double bedrooms. Bedroom one benefits from fitted wardrobes and French doors opening onto the pretty rear garden. Bedroom two is also a double bedroom with double glazed window to front aspect. There is a modern bathroom complete with shower over the bath. The kitchen breakfast room looks onto the rear garden and is fitted with a range of cupboards and work tops with a breakfast bar, and is adjacent to the dining room. The living room is cosy and peaceful and has a study area at the front.

There is off road parking to the front and generous lawned garden. A side gate gives access to the rear where you will find a very good size lawn and patio with views over fields behind.

There is much potential for extension, subject to planning etc, and viewing is advised.





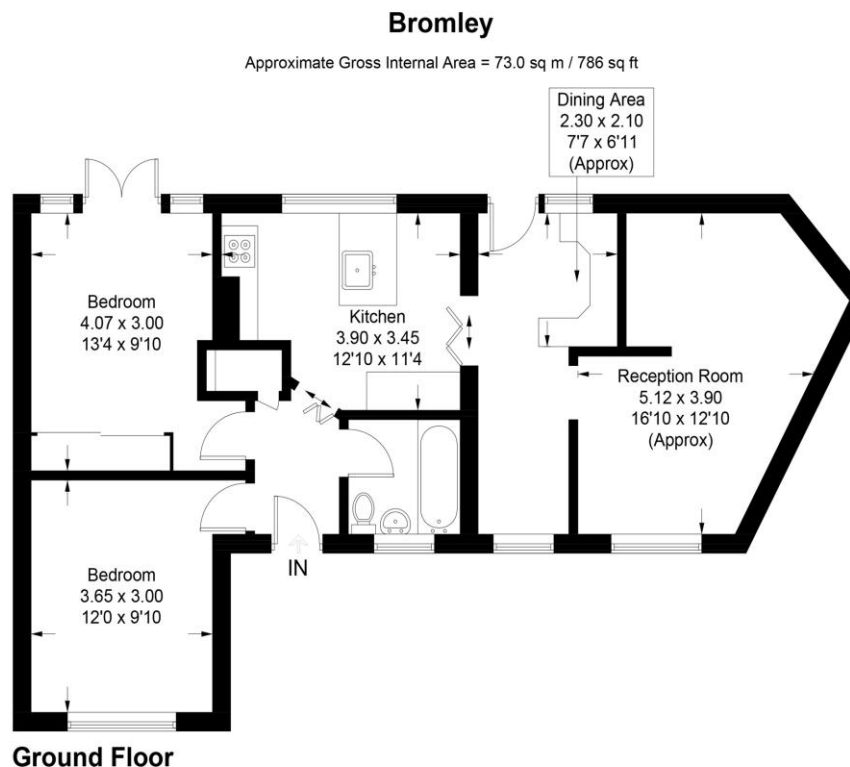
