Being presented to the market with no onward chain is this particularly spacious three bedroom detached bungalow situated within the ever popular North Hykeham area, enjoying local access to a wide range of amenities including shops, eateries, supermarkets, a leisure centre, parks and public houses and well as transport links and schooling. Requiring some modernisation/refurbishment, the property in brief comprises: entrance hall, lounge, fitted kitchen, conservatory with double doors opening to the rear garden, three bedrooms with fitted wardrobes and family bathroom. Outside, this property benefits from a driveway to the side providing off road parking, access to the detached garage and side access to the rear garden. Alongside the driveway is a low wall fronted area of lawn with flower and shrub borders and pathway to the front door. To the rear is a non overlooked garden which is mainly laid to lawn with mature flowers and shrubs. Early internal viewing is strongly recommended to appreciate this property in full.
