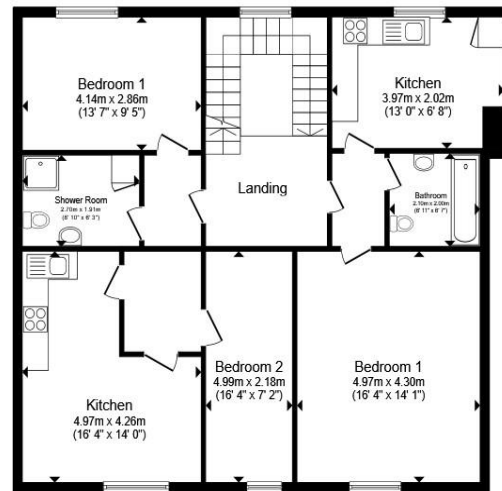

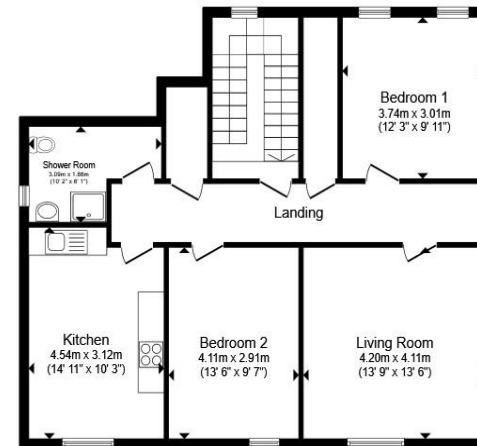




Ground Floor
