The property is set back from the road and approached via communal grounds with communal entrance door opening to communal hallway with stairs rising to first floor landing leading to private entrance door opening to:

Two ceiling light points, built-in storage cupboard, wood effect flooring, radiator and doors to:

Three windows to front aspect, two ceiling light points, wood effect flooring, two radiators and French style doors opening to balcony,

Ceiling light point and railings.

Window to rear aspect, ceiling light point, wall mounted boiler, radiator and a fitted kitchen comprising: a range of wall, drawer and base units with work surfaces over, inset sink and drainer unit with mixer tap over, space for cooker with extractor hood over, space for washing machine and fridge/freezer.

Bedroom One 13'2" max x 12'4" max

Window to front aspect, ceiling light point and radiator.

Bedroom Two 11' max x 7'7" max

Window to front aspect, ceiling light point, wood effect flooring and radiator.

Bathroom 7'9" max x 7'7" max

Obscured window to rear aspect, ceiling light point, extractor fan, part tiled walls, heated towel rail and a bathroom suite comprising: panelled bath with electric shower over, pedestal wash hand basin and low level flush w.c.

Set in communal grounds with communal bike shed and parking area providing one allocated parking space which is numbered 3.

- You're already part of the Shared Ownership scheme but want to move
- You own a home and want to move but can't afford the new home that meets your needs

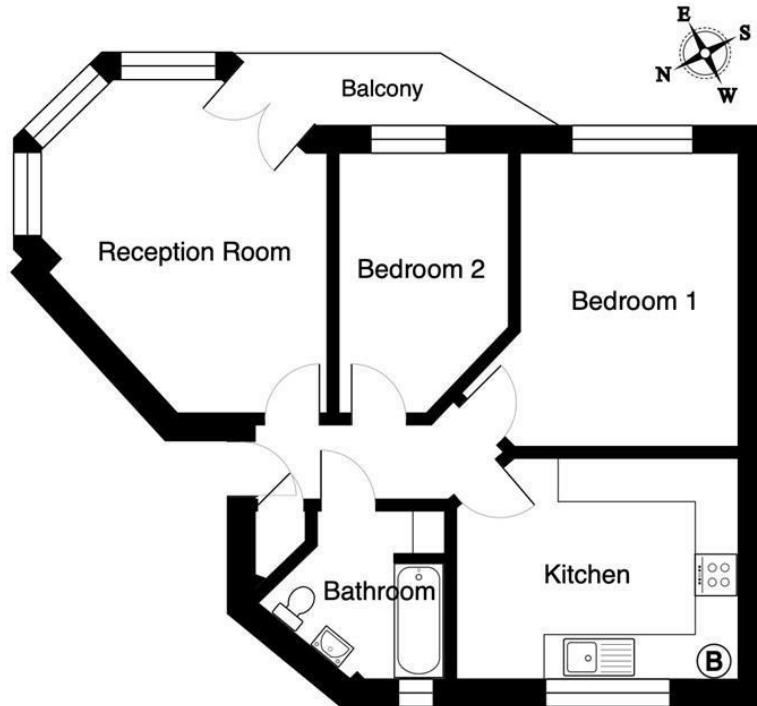
