SITUATION

Totnes is a bustling market town full of interest, with a range of independent shops and recreational facilities. The town is one of Devon's gems, full of colour and character that stems from a rich cultural, historical and archaeological heritage. The facilities include a hospital, a wide range of good local schools, a supermarket, an interesting range of independent shops and galleries, together with riverside walks, the Guild Hall, cinema, churches and its very own Norman Castle. There is a mainline railway station to London Paddington. Totnes allows easy communication with the rest of the country, the A38 Devon expressway is approximately 6 miles away, allowing speedy access to the cities of Exeter and Plymouth and the country beyond.

ACCOMMODATION

Westerwald House is accessed via Somerset Place and the communal car park. A gate leads to a natural stone path, flanked by an astroturf lawn and woodchipped planting area, with front door leading to:-

OPEN PLAN KITCHEN AND SITTING ROOM

A spacious sitting room with laminate flooring, benefitting from underfloor heating and a patio door allowing dual access to the front garden. A fitted kitchen with dual electric oven and 4 point induction hob. Selection of wall and floor cupboards, with an integrated dishwasher, washing machine and fridge freezer.

Partially tiled suite with a W.C and wash hand basin. Large storage cupboard housing the air source heating and hot water system.

STAIRS AND LANDING

The staircase is carpeted, rising to the first floor. Carpeted landing with a radiator and doors leading to:-

Carpeted double bedroom with two windows to side and a double built in wardrobe. Radiator.

EN-SUITE

A fitted suite with a shower, W.C, wash hand basin and a towel rail.

BEDROOM 2

Carpeted double bedroom with windows to front and side and a double built in wardrobe. Radiator.

BATHROOM

A fitted suite with a shower over bath, W.C, wash hand basin and a towel rail.

BEDROOM 3

Carpeted single bedroom with window to side and a double built wardrobe. Radiator.

OUTSIDE

The rear car park is mainly laid to tarmac, with allocated parking spaces, communal bin store and cycle store.
