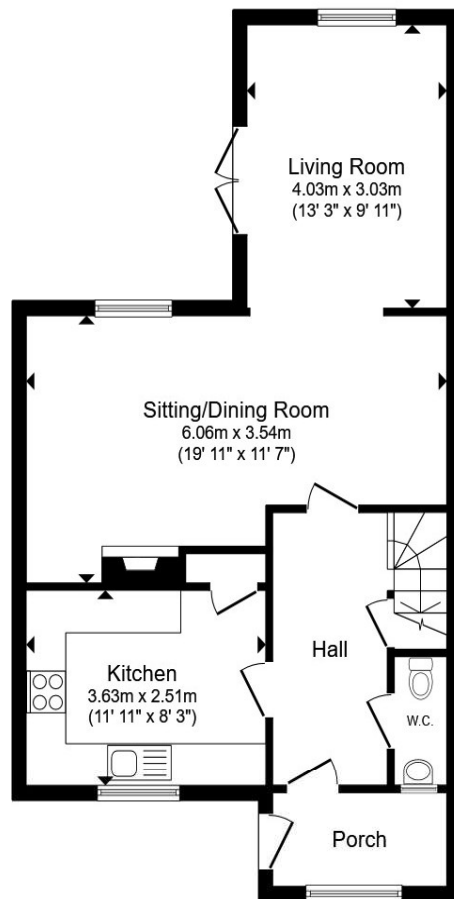

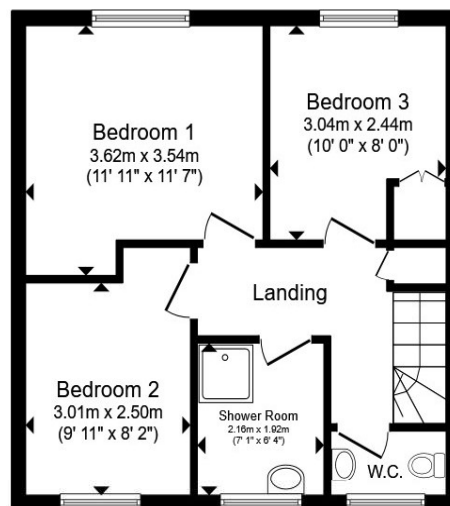

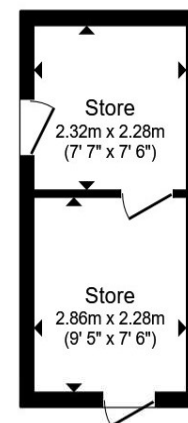




**Ground Floor**

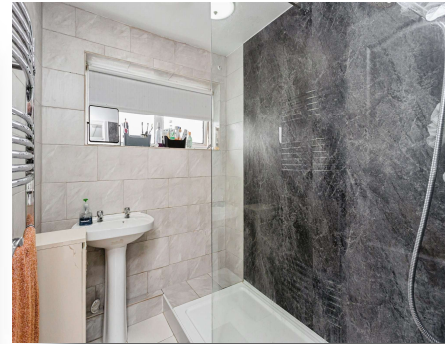
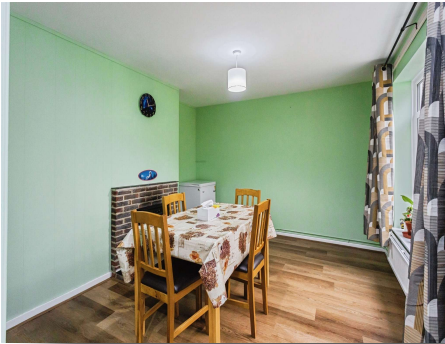
