



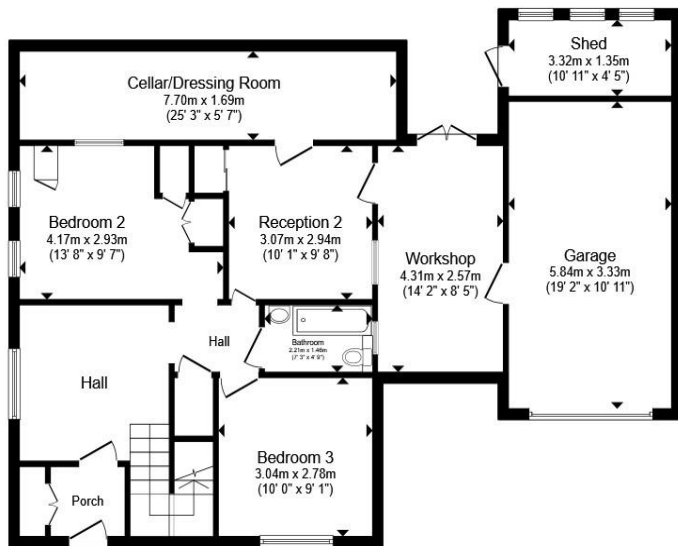

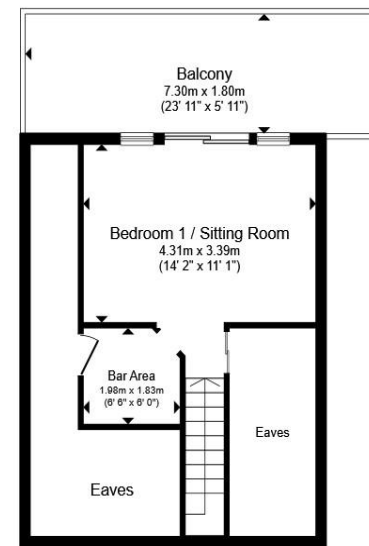




Ground Floor
