There is a good-sized wrap-around garden which is in need of work.

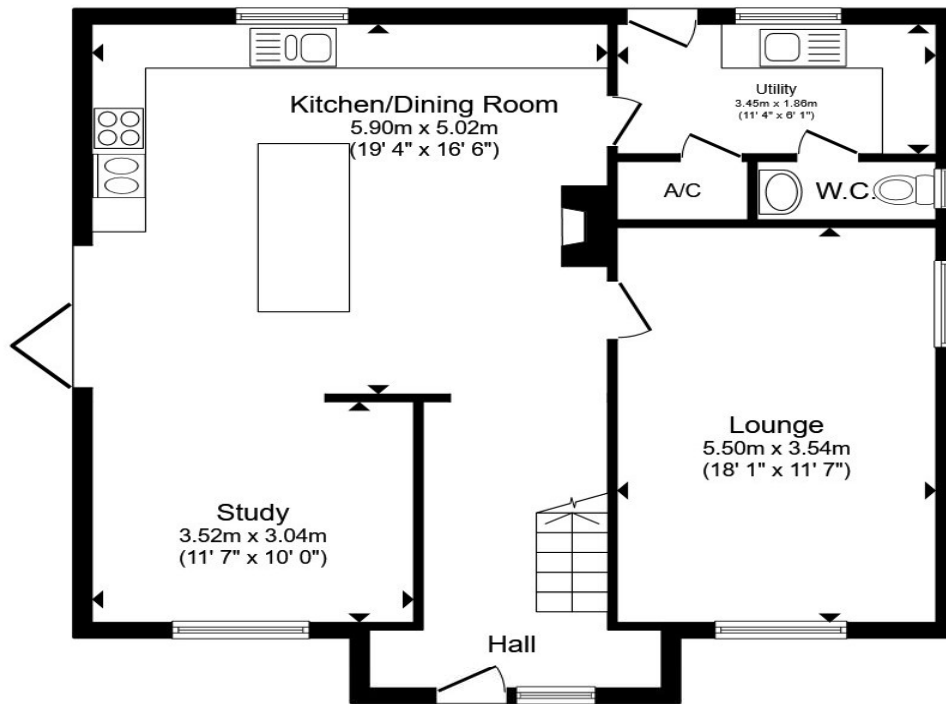

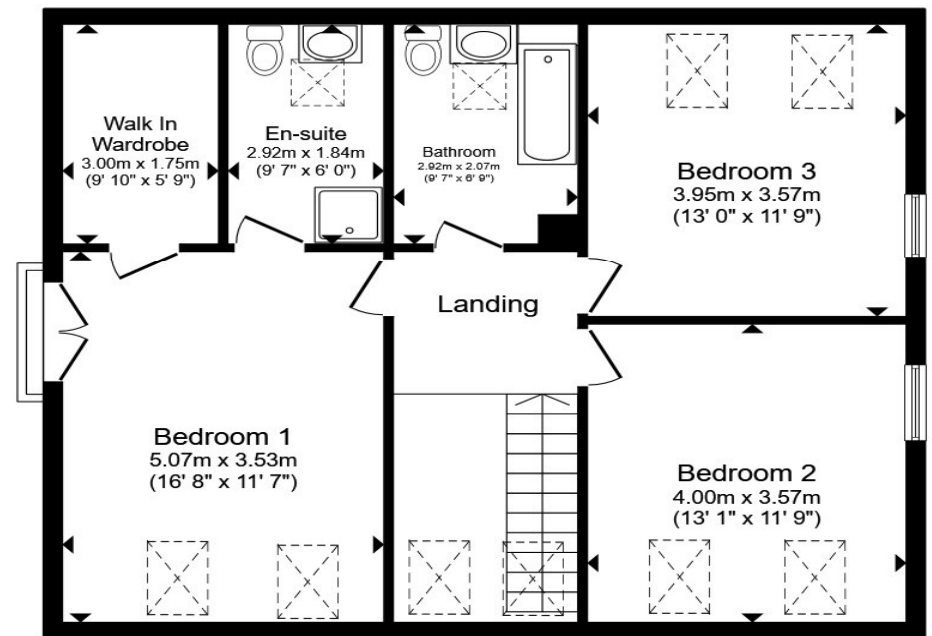
