SITUATION

9 Nynehead Mews is situated within the grounds of Nynehead Court and adjacent to All Saints Church. The two bedroomed mews house is in a courtyard development of single storey retirement properties in the stunning grounds of Nynehead Court, set in 13 acres of tendered parkland. Nynehead Court is one of the longest-standing care homes in the UK, the facilities within the estate include residential care, close care housing and grounds. The town of Wellington is within 1.5 miles where an excellent selection of shopping can be found. The M5 motorway is readily accessible being within 2 miles of the property and the County Town of Taunton approximately 8 miles offering an even greater selection of shopping facilities, restaurants, theatre and County Cricket Ground. There can also be found a main line rail link to London Paddington.

DESCRIPTION

Nynehead Mews was built in 2010 and was converted from the former stables and garages, it is a carefully blended mix of new build and conversion of the existing buildings. The design and finish is high standard and compliments the architectural quality and heritage of the surrounding estate. The property is safe and secure with independent living, comprising an entrance hall, an open plan living/dining and kitchen area, two bedrooms, en suite bathroom and wet room. It benefits from air source heating, double glazing and patio doors leading out to the open garden. Internal inspection is recommended.

ACCOMMODATION

Front door to the light and spacious entrance hallway with storage cupboards, access to the open plan living/dining and kitchen area with dual aspect and boasts a feature fireplace. There are TV and telephone points and two sets of French doors leading to a pergola and open grounds on two aspects. The kitchen comprises of a range of modern units with solid matt granite worktops with upstands and tiled walls. Integral units with shaker style cabinet doors including a combined eye level microwave, oven and grill, extractor hood, four ring induction hob, large fridge/freezer, washing

machine, tumble drier and a dishwasher.

Bedroom one is a double bedroom with TV, telephone and light points, built in wardrobe and dressing units, en suite bathroom with heated towel rails, built in basins and WC, granite work tops, extractor fan and a fitted cabinet. Bedroom two is also a double bedroom with tv and telephone. There is a separate large level shower room with heated towel rails, built in basins and W.C, granite work tops, extractor fan and a fitted cabinet.

DIRECTIONS

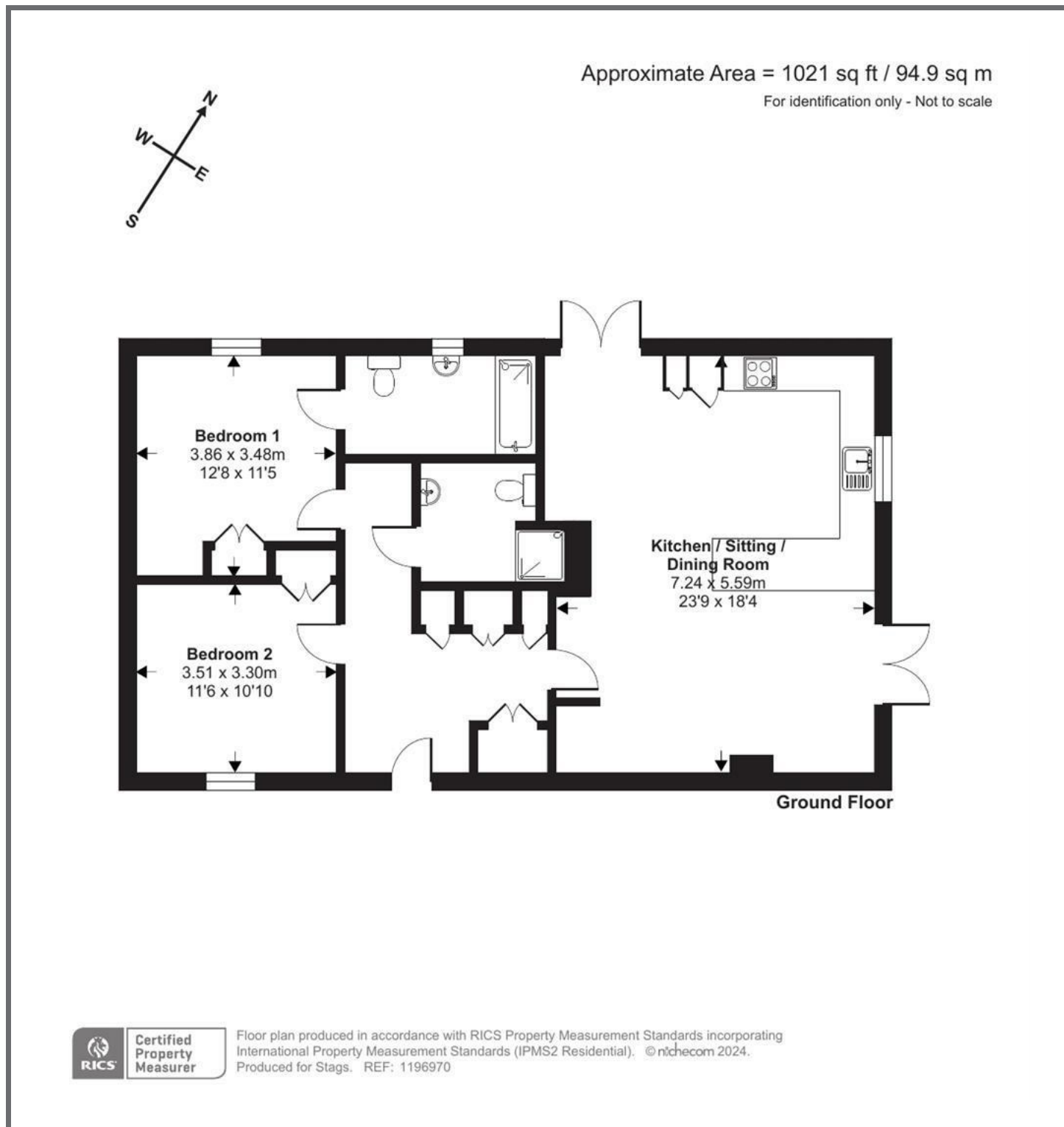
From junction 26 of the M5 motorway head towards Wellington and at the roundabout with the A38 take the second exit signposted Wellington.

After approximately half a mile at the next roundabout turn right signposted Nynehead. Continue along here for approximately 1 mile bearing left at the T junction whereupon Nynehead Court will be seen on the left hand side.
