



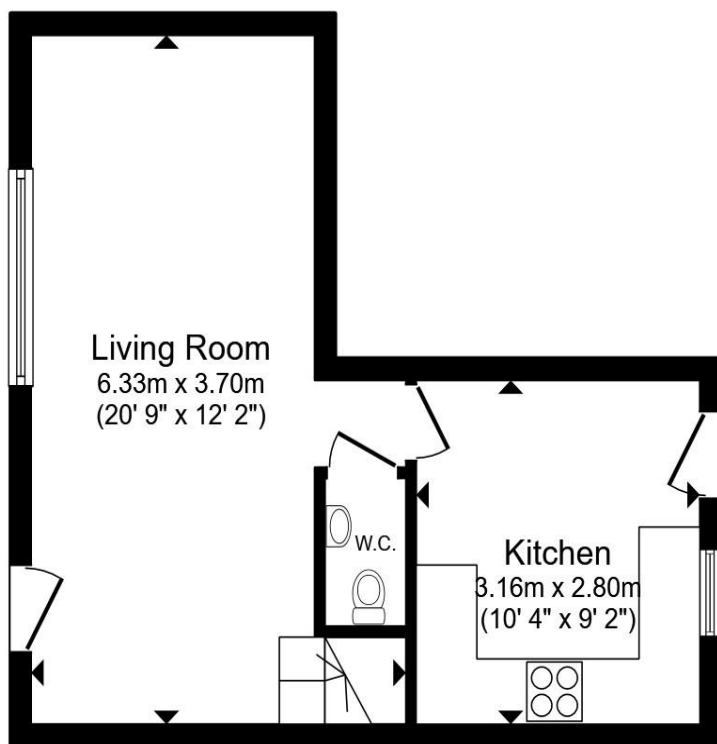

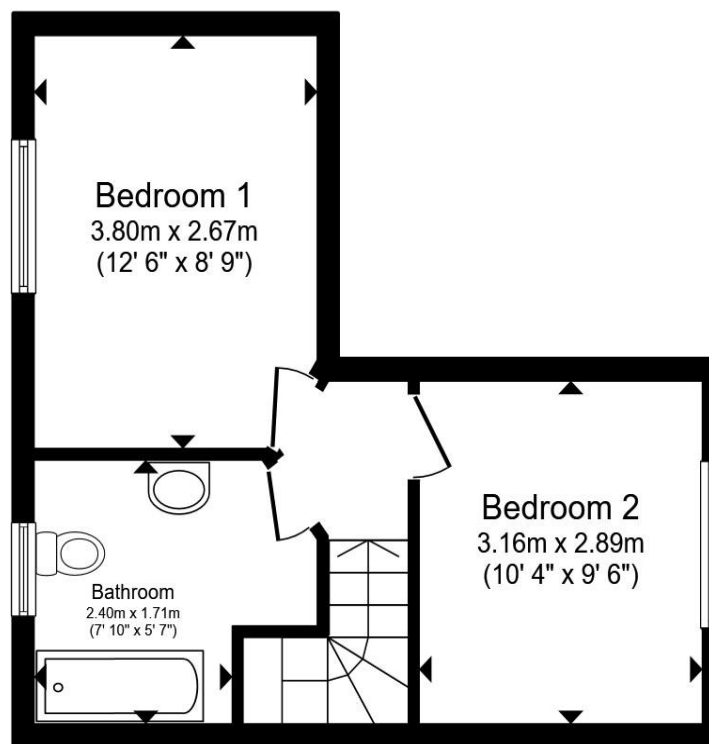

The ground floor comprises; Living room, Cloakroom with WC and hand wash basin, fitted kitchen with electric hob and oven, extractor and space for appliances with access to the rear garden.
