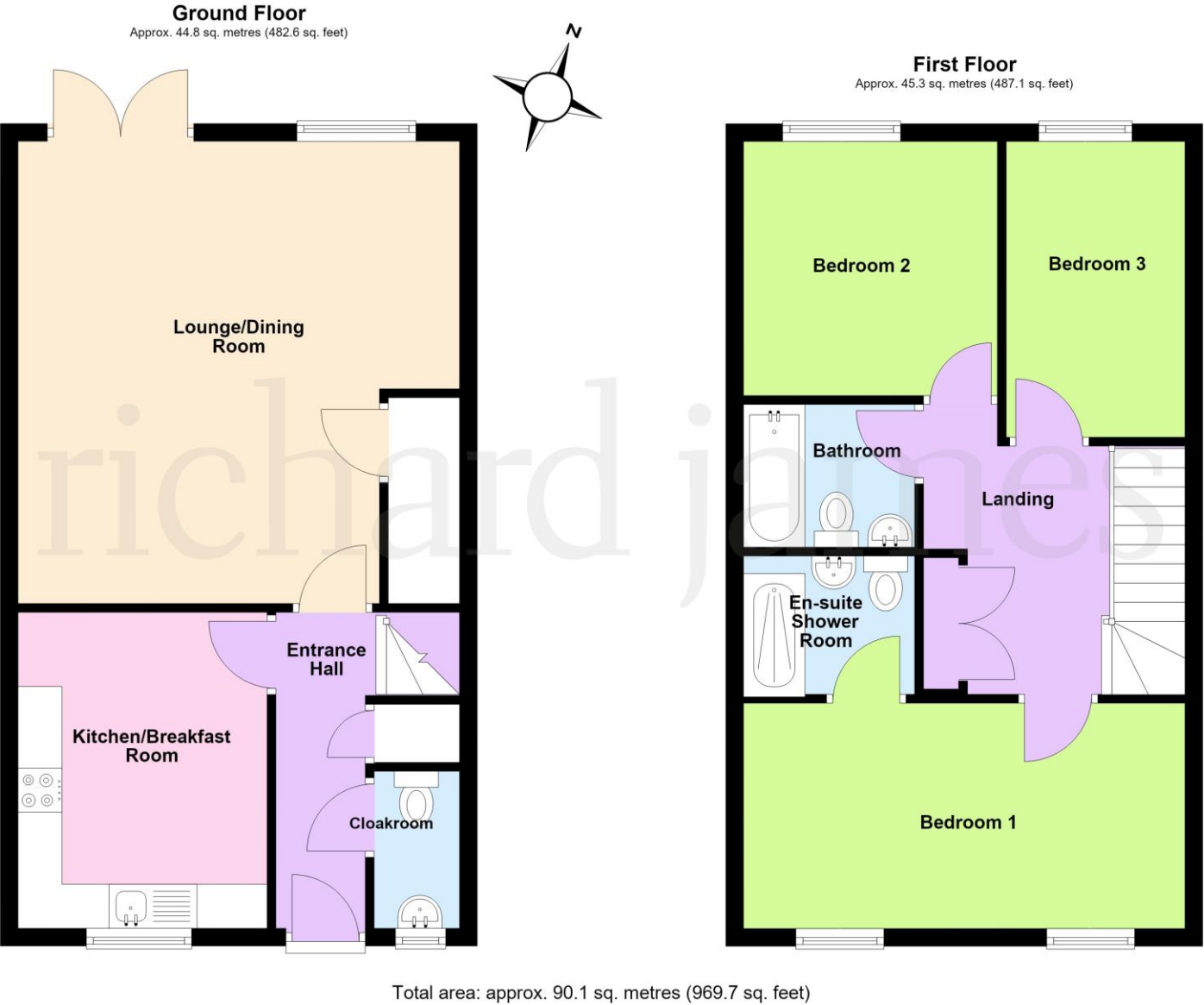

The property further offers a cloakroom, 17ft x 16ft lounge/dining room and a 11ft third bedroom. Viewing is highly recommended. The accommodation briefly comprises entrance hall, cloakroom, kitchen/breakfast room, lounge/dining room, master bedroom with ensuite shower room, two further bedrooms, bathroom, gardens to front and rear and single garage.
