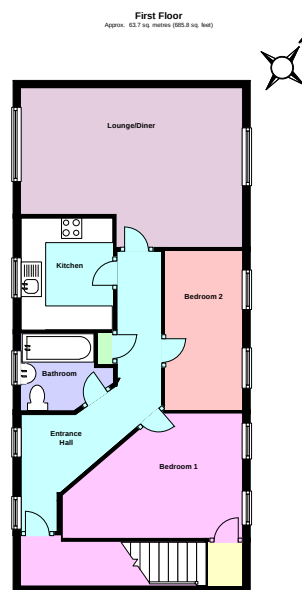




Excelsior Court Scarborough Street Irthlingborough NN9 5FE

Enter via entrance door to stairs rising to first floor landing, window to side aspect, door to:

Entrance Hall

Lounge 17' 9" x 12' 10" max. narrowing to 10' 1" (5.41m x 3.91m)

Kitchen 8' 7" x 7' 1" (2.62m x 2.16m) (This measurement includes the area occupied by the kitchen units.)

Bedroom One 14' 5" max. x 10' 0" max. irregular shape (4.39m x 3.05m)

Bedroom Two 12' 8" x 6' 8" (3.86m x 2.03m)

Tenant Requirements

- First month's rent of £700 pcm
- Deposit of £807.69
- Your details will be submitted to our referencing company Vouch, who will carry out a credit check and obtain previous landlord references and employment references
- Proof of identification (passport or driving licence and proof of address i.e. utility bill)
- Right to remain documents (if applicable)
- Holding deposit of £175.00 (one weeks' rent). This is to reserve a property, subject to referencing. Please note: This will be retained if any relevant person (including any guarantor(s)) withdraw from the tenancy, fail a Right-to-Rent check, provide materially significant false or misleading information, or fail to sign their tenancy agreement (and/or Deed of Guarantee) within 15 calendar days (or other Deadline for Agreement as mutually agreed in writing). This holding deposit will be returned within 15 days or apportioned to rent with the prospective tenants consent if referencing is successful.
